- That they are the President and Secretary respectively of the D. L. EVANS & COMPANY, an Idaho Corporation.
- That at a meeting of the shareholders of the corporation duly Held at Albion, County of Cassia, State of Idaho, on the 29th day of January, 1971, the following Resolution was adopted:

That Article Second of the Articles of Incorporation of D. L.
