Articles of incorporation of The Ato Land
and Live stock Company Limited.

Article I This certifies that the undersigned
have on this 2nd day of April 1906
formed a corporation for the purpose
hereinafter specified and which
shall be known as the Ato Land
and live stock Company limited
with such powers and privileges
as are allowed by Law.

Article II The purpose for which The
Company is formed is to buy and
sell real estate and live stock
all kinds

Article III The place where its principal
business is to be transacted is Ato
Bingham County Idaho.

Article IV The corporation is for the
period of twenty years.
