KNOW ALL MEN BY THESE PRESENTS, That We, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under and by virtue of the laws of the State of Idaho.

WE HEREBY CERTIFY:

FIRST: That the name of this corporation is ECHO COMMONS, INCORPORATED.

SECOND: That the objects and purposes for which this corporation is organized is as follows:

- To build, erect, construct, lease, purchase, or otherwise acquire, manage, occupy, maintain and operate buildings and improvements for hotel purposes, dwelling houses, apartment houses, office buildings, and lands; buildings for hotels, apartment houses, dwelling houses, office buildings and business structures of all kinds for the accommodation of the public and of individuals; to mortgage said real property and borrow money thereon by mortgage or otherwise, to sell or otherwise dispose of said real estate in whole or in part for cash or by taking purchase money, bonds and mortgages in payment therefor, or for valuable consideration of any character. To keep, manage, conduct and operate hotels, apartment houses, dwelling houses, and other lawful business ventures for the accommodation of the public and of individuals; and generally to deal with and act in relation to said real estate, and any and every part thereof, in any and every way, and to the fullest extent that a corporation organized under the laws of the State of Idaho is lawfully empowered to do.
- 2. To purchase, or otherwise acquire, own, sell, assign or otherwise transfer and convey, trade, deal in and with, goods, wares, merchandise and property of every class, variety

and description.

3. To hold, purchase, or otherwise acquire, to sell, assign, transfer, mortgage, pledge, or otherwise dispose of, shares of the capital stock, bonds, or other evidence of indebtedness created by any other corporation or corporations.

4. To make, enter into and execute contracts of every kind and character with individuals, firms, associations and corporations, private, public and municipal, and bodies politic, and with the Government of the United States, and of any state or district thereof.

5. This corporation shall have power to borrow or raise money without limit as to amount by the issue of or upon warrants, bonds, debentures, and other negotiable or transferable instruments, or other obligations of the corporation, and to secure the payment of any such obligation by mortgage, pledge, deed, indenture, agreement or other instrument of trust, or by other lien upon, assignment of, or agreement in regard to all or any part of the property of the corporation wherever situated, whether now owned or hereafter acquired.

6. To do each and every thing necessary, suitable or proper for the accomplishment of any of the purposes, or the attainment of any one or more of the objects herein enumerated, or which shall at any time appear conducive to or expedient for the protection or benefit of this corporation.

THIRD: That the term for which this corporation is to exist is perpetual.

FOURTH: That the location and post office address of the resgistered office of this corporation shall be 1409 Benton Street, Idaho Falls, Idaho.

FIFTH: That the amount of Capital Stock of this corporation shall be Fifty Thousand Dollars (\$50,000.00), to consist of One thousand (1,000) shares of common stock of the par value of Fifty (\$50.00) Dollars each.
