Dear Sir:

The following amendment to the Articles of Incorporation was adopted November 15, 1982 at a meeting of the members of the Good Samaritan League by majority vote of a quorum which was present.

Article VI shall be amended to read as follows:

That the corporate powers of this corporation shall be vested in a Board of Directors, the number of which shall be as stated in the By-Laws, but not less than six nor more than 15, to be elected as provided in the By-Laws of this Corporation. That the executive officers of this Corporation shall consist of a President, one or more Vice-Presidents as provided in the By-Laws, a Secretary and a Treasurer, to be elected as provided in the By-Laws. To be a Director or an officer, a person must be the holder of a membership certificate in this League and be in good standing. The powers and duties of the Directors and Officers of this Corporation shall be prescribed in the By-Laws.
