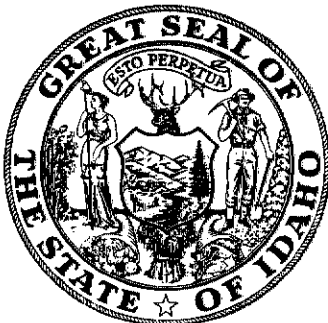

The undersigned, acting as the incorporator of a corporation under the Idaho Professional Service Corporation Act and the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

- (1) The name of the corporation is High Peaks Physical Therapy, P.A.
- (2) The period of its duration is perpetual.
- (3) The purpose for which the corporation is organized is to provide professional services in the practice of physical therapy services and all other purposes allowed by the laws of the State of Idaho.
