ARTICLE 1

The corporation shall be called Mi Casa Ministries, INCORPORATED STATE OF IDAHO

ARTICLE 2

Mi Casa Ministries is organized and incorporated exclusively as a non-profit religious organization under the laws of the State of Idaho, in accordance with Section 501 (c)(3) of the Internal Revenue Code of 1986 of the United States of America, as amended (or the corresponding provisions of any future United States Internal Revenue Law).

The purpose of Mi Casa Ministries is to be a Latin American Christian Church where people of all Spanish speaking nations can come together with the purpose of worshiping and serving our Lord Jesus Christ; and to be authentic, reproducible Christian disciples, full of the Holy Spirit, taking the message of salvation to the Spanish-speaking community of Boise, Idaho, the surrounding areas, the nation, and the world, according to the commandments of our Lord Jesus Christ. (Mark 16:15-18; Matthew 28:19-20)

Furthermore, Mi Casa Ministries will endeavor to impact the Spanish speaking community with the gospel of Christ by these specific means:

Evangelization of the world through the proclamation of the gospel of Jesus Christ through the spoken, written and electronic word, regular and special worship services, home discipleship meetings, Bible classes and Sunday School, Bible camps, retreats and conferences, evangelistic outreaches, television and radio ministries, the publication of Christian literature and music, ministry to the poor and needy, conducting baptisms, marriage ceremonies, and funerals, licensing and ordaining workers, establishing new congregations, sending and supporting missionaries at home and abroad, the implementation of a Christian Day School, and establishing a college or seminary.

We also endeavor to be a resource center for other churches and Christian ministries.

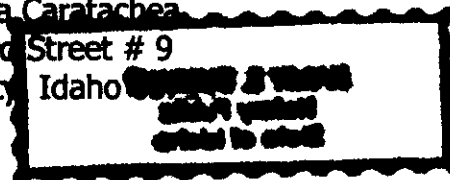

### ARTICLE 6

The mailing address of the corporation shall be 202 42<sup>nd</sup> Street, Garden City, Idaho, 83714.

### ARTICLE 7

The corporation does have voting members.

### ARTICLE 8

The real property of the congregation shall not be disposed of or encumbered in any manner except by resolutions adopted by a two-thirds majority witness at a legal meeting of the church. All deeds and conveyances shall be executed and acknowledged in a manner provided by the statutes of the State of Idaho relating to corporations.

If the congregation shall at any time decide to totally disband, the property and all rights connected therewith shall be irrevocably dedicated to Christian purposes, and upon liquidation, dissolution, or abandonment by the congregation, after providing for the debts and obligations thereof, the remaining assets will not inure to the benefit of any private person, but will be distributed to a church, a non-profit fund, foundation or corporation which is organized and operated exclusively for Christian purposes, and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code, such disposition of the congregation's property being made by at least two-third's majority witness of the voting members present at a duly called meeting.

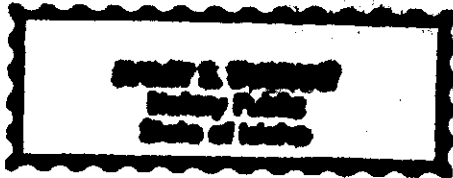
