ARTICLES OF INCORPORATION

We, the undersigned, incorporators, <sup>being of full legal age and U.S. Citizens</sup> /hereby associate ourselves together to form and establish a corporation not for profit under the laws of the State of Idaho pursuant to I.C. 30-1101, et seq.

FIRST: The name of the corporation is PARADISE VALLEY BIBLE CHURCH, INC.

SECOND: The location of its principal place of business in this state is Bonners Ferry, Idaho.

THIRD: The location of its registered office in this state is Bonners Ferry, Idaho.

FOURTH: This corporation is organized NOT for profit and the objects and purposes to be transacted and carried on are:

The object, business, and purpose of this corporation is nonpolitical, and shall be devoted to promoting the gospel of Jesus Christ, the study of the bible, practice and promotion of Christianity, and to uphold and maintain the constitution of the United States of America, and to assist in the maintaining of law and order; to safeguard and transmit to posterity the purity and righteousness of individual freedom, and the teaching of the bible, as well as to teach the same to our individual members and to the community at large; to assist in charitable work of any nature deemed beneficial and to the best interests of the order and to society as a whole, and to raise funds for carrying the same into effect in any manner allowed by the constitution and the bylaws of the order, and permitted under the laws of the State of Idaho and the Constitution of the United States of America.

The corporation shall not have authority to issue capital stock.

The corporation, pursuant to its purposes, shall have the
