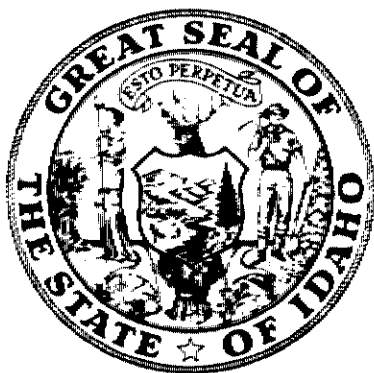

ARTICLES OF DISSOLUTION

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, acting under their authority as the incorporators of a corporation under the provisions of the Idaho Business Corporation Act, do voluntarily dissolve their corporation under Title 30, Chapter 1 - 82 of the Idaho Code; and do hereby certify as follows:

ARTICLE I

The name of the corporation is THE BACKDOOR PRESS, INC.

ARTICLE II

The certificate of incorporation was issued on the 16th day of September, 1988.

ARTICLE III

Said corporation has fulfilled the following requirements for voluntary dissolution as listed:

- A. The corporation has not issued any of its shares.
- B. The corporation has not commenced business.
- C. All moneys paid in on subscriptions for shares, less moneys disbursed for necessary expenses, have been returned to those entitled thereto.
- D. No debts of the corporation remained unpaid.
