ARTICLES OF INCORPORATION

OF

SNAKE RIVER VALLEY ALZHEIMERS DISEASE AND RELATED

To further common purposes, the members agree to organize under these articles of incorporation.

ARTICLE ONE

NAME

The name of this corporation shall be Snake River Valley Alzheimers Disease and Related Brain Disorders Support Group, Inc., which in these articles shall sometimes be referred to as the "Group."

ARTICLE TWO

PRINCIPAL OFFICE

The initial principal office of the Group and Registered Agent shall be Route 4 Box 99, 2885 Mill Road, Idaho Falls, Idaho 83401. The Group may have such offices as may from time to time be designated by its Board of Directors. The initial registered agent is Carol Rounds.

ARTICLE THREE

PURPOSES - NONPROFIT CORPORATION

The purposes of this Group shall be:

1. To promote and effect improved dignity and quality of life for all persons affected with Alzheimers Disease and related brain disorders.

2. To bring needed services to the families and friends of Alzheimers Disease and related disorders in and around the surrounding communities.
3. To help the surrounding communities benefit from the resources of knowledge, experience, wisdom, skills, concern, energy and service for the Alzheimers Disease and related brain disordered families.
4. To promote and effect family and individual support to the afflicted families of Alzheimers Disease and related brain disorders.
5. To promote education of the effects of Alzheimers Disease, such as physical, emotional and social effects.
6. To promote research in the cause and cure of Alzheimers Disease and related brain disorders.
7. To encourage regular monthly meetings for the purpose of mutual exchange and support of ideas and concerns.
8. To do anything necessary and proper for the accomplishment of the purposes stated herein, not inconsistent with the corporation laws of the State of Idaho.

The Group is organized and operated exclusively for the above-stated purposes, and for other nonprofit purposes, and no part of any net earnings shall inure to the benefit of any private member.

#### ARTICLE FOUR

##### DURATION

The duration of this Corporation shall be perpetual.

#### ARTICLE FIVE

##### STOCK

The Corporation shall not issue stock to any private person or individual or business entity organized for profit, and no dividends or pecuniary profit shall be declared or paid to the members hereof.

#### ARTICLE SIX

#### ARTICLE SEVEN

##### BOARD OF DIRECTORS

The board of directors of the corporation shall consist of no fewer than five (5) and no more than twenty-one (21) members.

The number of directors constituting the initial board of directors shall be five (5), and the names and addresses of the persons who are to serve as directors until the first annual election of directors or until their successors are elected and shall qualify are:

#### ARTICLE EIGHT

##### LIMITATION ON ACTIVITIES AND EXPENDITURES

All of the properties and assets of this corporation shall be, and are, irrevocably dedicated to charitable, scientific and educational purposes and no part of the monies, properties or assets of this corporation, upon dissolution or otherwise, shall inure to the benefit of any private person or individual or any stockholders of this corporation, except as such stockholder may be a corporation organized and operated exclusively for charitable, scientific or educational purposes,

including medical research, and which is exempt from taxation, and particularly the Federal Income Tax. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these articles, the organization shall not carry on any other activities not permitted by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).


#### ARTICLE NINE

##### DISSOLUTION


Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated


exclusively for charitable, educational, or scientific purposes and which shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine; provided however, and subject to the above limitations, if any of such assets have been acquired under a Federal grant or contract, their disposition shall be made in accordance with the appropriate instructions of the governmental official responsible under the law for the providing of such instructions under such circumstances. Any of such assets not so disposed of shall be disposed of by the District Court of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.


