Articles of Incorporation for Stebel OD Holdings, P.C.

**Optional Articles**

Article 8: Directors. The initial directors of the corporation are Todd Stebel, O.D. and Holly Stebel, O.D. The corporation may have up to but no greater than three directors.

Article 9: Limitation of Liability and Indemnification of Directors and Officers. To the fullest extent allowed by Idaho law, the liability of a director or officer to the corporation or its shareholders for money damages for any action taken or any failure to take any action, as a director or officer, it is eliminated except for liability as provided in the Idaho Business Corporations Act. The corporation shall indemnify and pay any expenses on behalf of any director or officer for any liability to any person for any action taken, or any failure to take any action, as an officer or director, except liability as provided by the Idaho Business Corporations Act.
