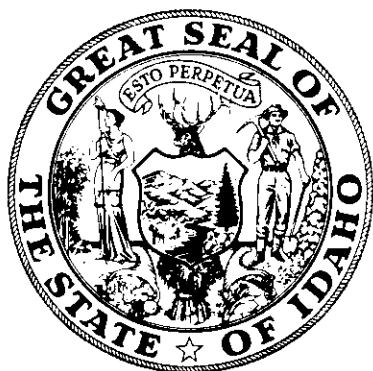

ARTICLES OF INCORPORATION

OF

SOLBERG LOGGING, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, KENNETH A. SOLBERG and JoANN SOLBERG, who are of legal age, and have this day voluntarily associated ourselves together for the purpose of forming a corporation, under and pursuant to the laws of the State of Idaho, and we do thereby certify:

ARTICLE I:

That the name of this corporation shall be:

"SOLBERG LOGGING, INC."

ARTICLE II:

That the duration and existence of this corporation shall be perpetual.

ARTICLE III:

The purposes of this corporation are as follows:

To harvest timber, manufacture and sell logs, lumber and wood products of all kinds and of every nature and to engage in any other practice commonly associated with the logging industry, and to engage in any other activity for the promotion of this corporation or as authorized by the statutes of the State of Idaho.

ARTICLE IV:

The location of the office of the corporation will be at North 8868 Reed Road, Hayden Lake, Idaho. The registered agent at the above office is KENNETH A. SOLBERG.

ARTICLE V:

The total authorized stock of this corporation shall be Thirty Thousand Dollars (\$30,000.00), divided into three hundred (300) shares of One Hundred Dollars (\$100.00) par value each, and that all stock shall be of the same kind.

ARTICLE VI:

That the only authorized stocks will be the common stock of said corporation with equal rights, preferences and restrictions.
