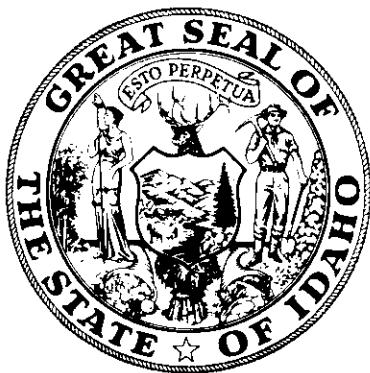

WE, THE UNDERSIGNED, Hereby incorporate ourselves under the Idaho  
Business Corporation Act [§§30-1-1ff. I.C.].

ARTICLE I

The name of the corporation is:
