ARTICLES OF INCORPORATION

OF

VALLEY VIEW CHURCH OF THE NAZARENIE An Idaho Non-Profit Corporation

THAT I, the undersigned person, acting as the incorporator of a corporation under the provisions of and in accordance with Title 30, Chapter 3, of the Idaho Code and consistent with the provisions of the Internal Revenue Code Section 501(c)(3), do hereby form and incorporate myself into a voluntary religious association for the purpose of establishing and maintaining religious worship, and promoting the Gospel of Jesus Christ, and to that end, adopt the following Articles of Incorporation for such corporation.

ARTICLE I: NAME

This corporation shall be known as "VALLEY VIEW CHURCH OF THE NAZARENE," by which name it shall contract and be contracted with, sue and be sued, and transact all of its business and the existence of said corporation shall be perpetual.

ARTICLE II: REGISTERED OFFICE AND AGENT

The address of the initial registered office of the corporation shall be Rt. 1, Box 300, Kamiah, Idaho 83536. The name of the initial registered agent of the corporation at such address shall be Russell Cramer.

ARTICLE III: PURPOSES

The objects and purposes for which this corporation is formed are as follows:

- 1. To establish and maintain a local congregation of the Church of the Nazarene.
- 2. To spread the Gospel of Jesus Christ, promote holiness and the worship of God among its members and attendants, and the practice of Christian virtues inculcated in the Holy Scriptures.
- 3. To employ and discharge ordained ministers of the Gospel, and others, to conduct and carry on divine services at the place of worship, and elsewhere, and to collect and disburse all necessary funds for the maintenance of said corporation and ecclesiastical body being the local congregation known as Valley View Church of the Nazarene.
- 4. To provide appropriate religious education and training for its members and those attending its church school and other educational meetings and classes.
- 5. To acquire property whether real, personal or mixed, by purchase, gift, legacy, bequest or any other manner and to borrow money, issue bonds or notes, and all other documents necessary or appropriate in carrying out the objects and purposes set forth in this Article III.
- 6. To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or incidental to the powers named, or which shall at any time appear conducive or expedient for the promotion of its welfare, and the accomplishment of the objects herein enumerated.
- 7. All of the objects, purposes, and powers of the corporation shall be subject to and in accordance with the government

and discipline of the Church of the Nazarene, as is from time to time set forth in the official <u>Manual</u> of said Church published by the authority of the General Assembly of the Church of the Nazarene.

ARTICLE IV: BYLAWS

The corporation shall provide Bylaws for its government not inconsistent with these Articles of Incorporation, the laws of the State of Idaho and the United States, nor inconsistent with the government and discipline of the Church of the Nazarene as may be from time to time provided in the Official Manual of said Church.

ARTICLE V: AMENDMENT OF ARTICLES

These Articles of Incorporation may be amended by a vote of sixty-seven percent (67%) of the members present at any annual meeting or special meeting called for such purposes provided that such notice of the proposed amendment shall be given to the membership in accordance with the provisions of the Bylaws and in accordance with any requirements of the Church of the Nazarene as they are from time to time set forth in the official Manual of said Church published by the authority of the General Assembly of the Church of the Nazarene.

ARTICLE VI: MEMBERSHIP

The terms of admission to membership in this corporation shall consist of membership in good standing in the ecclesiastical body known as Valley View Church of the Nazarene, and each member in good standing in such ecclesiastical body shall by virtue thereof be a member of this corporation.

ARTICLE VII: TRUSTEES

The affairs of the corporation shall be managed by a Board of Trustees, which shall consist of not less than three (3) and not more than nine (9) members of the corporation in good standing. The number, tenure of office, manner of election and filling of vacancies shall be as provided in the Bylaws of the corporation. ARTICLE VIII: OFFICERS

The officers of the corporation shall consist of a President, one or more Vice Presidents, a Secretary and a Treasurer. The Secretary and Treasurer may be the same person. The officers shall be elected by the Board of Trustees from among its members, and the tenure of office, manner of election and filling of vacancies shall be as provided in the Bylaws of the corporation.

ARTICLE IX: DISSOLUTION

Upon the dissolution of the corporation, the Board of Trustees shall, after paying or making provisions for the payment of all the liabilities of the corporation, distribute all of the assets of the corporation to the Northwest District Church of the Nazarene, Inc., a Washington non-profit corporation, located in Spokane, Washington.
