

4. The number of shares outstanding at the time of adoption of the amendment was 10,000, all of which were of the same class and entitled to vote on the amendment.


5. All 10,000 shares outstanding and entitled to vote on the amendment voted for the amendment.


6. The amendment does not provide for the exchange, reclassification or exchange or cancellation of issued shares of said corporation.




