KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, being a bona fide citizen of the United States of America, over the age of 21 years, does, under and pursuant to the general corporation laws of the State of Idaho, hereby organize, constitute and associate ourselves, and such other persons as may hereafter become associated with us, into a body politic and corporate, and to that end execute the following ARTICLES OF INCORPORATION and do hereby set forth and declare as follows:

I

The name of the corporation is, and shall be, MAVERICK DRILLING, INCORPORATED.

II

This corporation shall have perpetual existence.

III

The initial principal office and the initial registered office of this corporation shall be 4941 Whitaker Road., Chubbick, Idaho, 83202, and that other offices for the transaction of the business of the corporation shall be established by the Board of Directors from time to time, both within and outside of the State of Idaho, and that the meeting of the Board of Directors may be had pursuant to the provisions of the

IV

The purposes for which the corporation is formed are as follows:

- a. To purchase, own, sell, lease, improve, equip, operate and engage in the business of drilling wells.
- b. To purchase, sell, hold, acquire, own, mortgage, transfer, lease, exchange, trade or dispose of all types of real estate and personal property for any of the purposes aforesaid.
- c. To purchase, sell, hold, acquire, own, mortgage, hypothecate, convey, improve, transfer, lease, exchange, trade and dispose of real and personal property.
- d. To invest the capital of the company for any of the purposes aforesaid and in building or otherwise improving or adding to the market value of the lands or other properties from time to time acquired by the company.
- e. In general, but in connection with the foregoing, the Company may carry on any other business, and have and exercise all the powers conferred by the laws of the State of Idaho, upon corporations formed under the laws of said state; it being expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the general powers of the Company.

V

The corporate powers, business and property of the Company shall be exercised, conducted and controlled by a Board of Directors consisting of three persons.

VI

The amount of the authorized capital stock of this corporation shall be Ten thousand dollars (\$10,000) divided into ten thousand shares of the par value of one dollar (\$1.00) per share.

VII

The amount of the said capital stock i.e., ten thousand shares (10,000) shall be non-assessable.

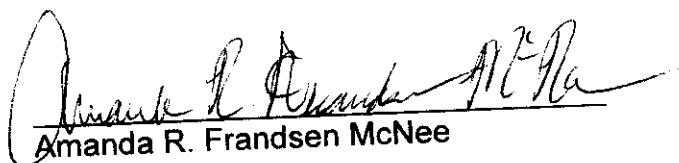
