# ARTICLES OF INCORPORATION OF WALIN, Inc.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned natural persons of lawful age and citizens of the United States, for the purpose of forming a corporation pursuant to the provisions of the Idaho Business Corporation Act (Title 30, Idaho Code) do hereby certify as follows:

# FIRST

The name of the Corporation is WALIN, Inc.

# SECOND

The Corporation is to be perpetual.

## THIRD

The purpose of this Corporation is to transact any and all lawful business.

#### FOURTH

The Corporation shall have authority to issue 50,000 shares of one class of common stock. The stock shall have a par value of \$1.00. The stock shall not be issued until they are fully paid for.

# **FIFTH**

All the shares of stock issued shall be common stock and be of equal value without preferences, limitations or differences in relative rights to other shares.

# SIXTH

The stockholders of the corporation shall have pre-emptive and preferential rights of subscription to any shares of stock of the Corporation, whether now or hereafter authorized, or to any obligations of the Corporation convertible into stock. The Corporation shall offer to the stockholders first any stock or obligations issued by the Corporation.
