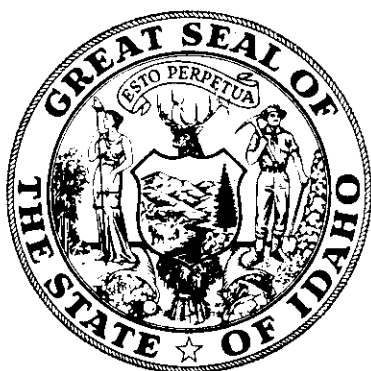

ARTICLES OF INCORPORATION  
OF  
RON GREEN BUILDERS, INCORPORATED  
SECRETARY OF  
STATE

The undersigned hereby establishes a general business corporation pursuant to the Idaho Business Corporation Act and adopts the following charter:

1. The name of the corporation is Ron Green Builders, incorporated..

2. The corporation shall commence on June 18, 1984, and the period of its duration is perpetual.

3. The purposes for which the corporation is organized includes the transaction of any or all lawful business, including, but not limited to, construction business.

4. The address of the initial registered office is 2399 S. Orchard, Suite 202, Boise, Idaho. The name of its original registered agent at such address is Michael J. Staab, Esq.

5. The initial Board of directors who are to serve as directors until the first meeting of shareholders or until their successors are elected and shall qualify are as follows:

3 6. The Board of Directors shall consist of one or more  
4 shareholders of the corporation as specified in its By-Laws,  
5 elected by the shareholders of the corporation.

6 7. Each director shall hold office until the next  
7 annual meeting of the corporation or until his successor shall  
8 have been duly elected and qualified.

9 8. The officers of the corporation shall be a presi-  
10 dent and secretary/treasurer, and such other officers as the  
11 Board of Directors shall designate from time to time.

12 9. The officers of the corporation shall be elected by  
13 the Board of Directors and shall hold office until the next an-  
14 nual meeting of the board or until their successors shall have  
15 been duly elected and qualified.

16 10. The duties and powers of the officers shall be such  
17 as are designated by the Board of Directors.

18 11. The aggregate number of shares which the  
19 corporation shall have authority to issue is 10,000 shares with  
20 no par value per share. The determination on no par value will  
21 be determined by the Board of Directors, as to the consideration  
22 to be paid for such shares.

23 12. Shares shall be voted only by the holder of record  
24 or another shareholder of the corporation in accordance with a  
25 written proxy executed by a holder of record.

26 13. The shares of the corporation held by a deceased or  
27 retired shareholder shall be either redeemed or cancelled by the  
28 corporation, or transferred to another shareholder within six


1 months after the date of death or retirement. Shares shall not  
2 be transferred to non-shareholders without first being offered  
3 at their fair market value to the remaining shareholders of the  
4 corporation. Shares not so redeemed or transferred within the  
5 required period of time shall be cancelled at the end of such  
6 period.
