

ARTICLES OF INCORPORATION
OF
RON GREEN BUILDERS, INCORPORATED
SECRETARY OF
STATE

The undersigned hereby establishes a general business corporation pursuant to the Idaho Business Corporation Act and adopts the following charter:

9 1. The name of the corporation is Ron Green Builders,
10 incorporated..

11 2. The corporation shall commence on June 18, 1984,
12 and the period of its duration is perpetual.

13 3. The purposes for which the corporation is organized
14 includes the transaction of any or all lawful business, includ-
15 ing, but not limited to, construction business.

16 4. The address of the initial registered office is
17 2399 S. Orchard, Suite 202, Boise, Idaho. The name of its orig-
18 inal registered agent at such address is Michael J. Staab, Esq.

19 5. The initial Board of directors who are to serve as
20 directors until the first meeting of shareholders or until their
21 successors are elected and shall qualify are as follows:

2 6. The Board of Directors shall consist of one or more
3 shareholders of the corporation as specified in its By-Laws,
4 elected by the shareholders of the corporation.
5

6 7. Each director shall hold office until the next
7 annual meeting of the corporation or until his successor shall
8 have been duly elected and qualified.
9

10 8. The officers of the corporation shall be a presi-
11 dent and secretary/treasurer, and such other officers as the
12 Board of Directors shall designate from time to time.
13

14 9. The officers of the corporation shall be elected by
15 the Board of Directors and shall hold office until the next an-
16 nual meeting of the board or until their successors shall have
17 been duly elected and qualified.
18

19 10. The duties and powers of the officers shall be such
20 as are designated by the Board of Directors.
21

22 11. The aggregate number of shares which the
23 corporation shall have authority to issue is 10,000 shares with
24 no par value per share. The determination on no par value will
25 be determined by the Board of Directors, as to the consideration
26 to be paid for such shares.

28 12. Shares shall be voted only by the holder of record
29 or another shareholder of the corporation in accordance with a
30 written proxy executed by a holder of record.
31

32 13. The shares of the corporation held by a deceased or
33 retired shareholder shall be either redeemed or cancelled by the
34 corporation, or transferred to another shareholder within six
35

1 months after the date of death or retirement. Shares shall not
2 be transferred to non-shareholders without first being offered
3 at their fair market value to the remaining shareholders of the
4 corporation. Shares not so redeemed or transferred within the
5 required period of time shall be cancelled at the end of such
6 period.
