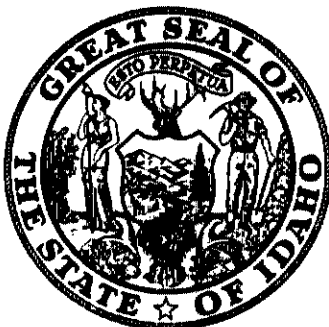
### CERTIFICATE OF INCORPORATION OF

**ARTICLES OF INCORPORATION  
OF  
FREMONT ECONOMIC ACTION TEAM, INC.**

**We, the undersigned, do hereby voluntarily associate ourselves together for the purpose of forming a nonprofit corporation under the statutes of the State of Idaho.**

**ARTICLE I**

**The name of the corporation shall be: Fremont Economic Action Team, Inc.**

**ARTICLE II**

**The corporation shall be a nonprofit corporation.**

**ARTICLE III**

**The period of duration shall be perpetual.**

**ARTICLE IV**

**The purposes for which the corporation is organized are:**

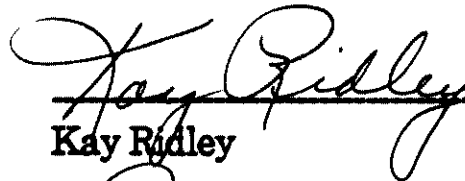

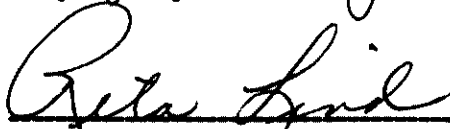
