The undersigned incorporator(s), desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt(s) the following articles of incorporation:

ARTICLE ONE
Name

The name of the corporation is LC, Inc..

ARTICLE TWO
Purposes

The purpose of the corporation is to own and operate a Color Tile franchise.

ARTICLE THREE
Duration

The period of duration of the corporation is perpetual.

ARTICLE FOUR
Registered Office and Agents
