## ARTICLES OF INCORPORATION

OF

Nov 7 3 23 PM '79'

IDAHO RAIL ORGANIZING NETWORK, LIMITED

The undersigned, acting as incorporator of a corporation under the Idaho Nonprofit Corporation Act, adopts the following articles of incorporation:

## ARTICLE I

The name of the corporation is: IDAHO RAIL ORGANIZING NETWORK, LIMITED.

#### ARTICLE II

The period of duration of the corporation shall be perpetual.

## ARTICLE III

The purposes for which the nonprofit corporation is organized are: To promote, organize and plan the use of public transportation of persons and freight; to develop and utilize present and future means and modes of transportation for the general benefit of the public, and to do all lawful acts and things incidental thereto; to research and plan such transportation and related facilities and to act as consultants and/or agents for other persons or organizations, private or public, in connection with such transportation.

# ARTICLE IV

The nonprofit corporation will be a membership corporation with one (1) class of member as provided in the corporation's Bylaws.

## ARTICLE V

Directors of the nonprofit corporation shall qualify and be elected in the manner provided by the Bylaws.

#### ARTICLE VI

## ARTICLE VII

### ARTICLE IX

The nonprofit corporation shall have all the powers granted nonprofit corporations under the laws of the State of Idaho. However, notwithstanding anything herein to the contrary, the nonprofit corporation shall exercise only such powers as are in furtherance of the exempt purposes of organizations set forth in the subsection of section 501(c) of the Internal Revenue Code of 1954, under which the corporation chooses to qualify for exemption, as the same now exists or as it may be amended from time to time.

## ARTICLE X

In the event of the dissolution of the nonprofit corporation, no member shall be entitled to any distribution or division of its remaining property or its proceeds and the balance of all money and other property received by the nonprofit corporation from any source after the payment of all debts and obligations of the nonprofit corporation, shall be used or distributed exclusively for the purposes within the intendment of section 501(c) of the Internal Revenue Code of 1954, as the same now exists or as it may be amended from time to time.
