



Board of Directors' Dissolution Recommendation

The undersigned, Herman T Sakimoto DDS, being the sole member of the current Board of Directors of Herman T Sakimoto DDS PA (the *Corporation*) hereby waives any and all notice to any meeting of the Board of Directors (per *IDAHO CODE* § 30-1-823) for the purpose of considering recommending to the shareholders and hereby resolves without any meeting (per *IDAHO CODE* § 30-1-821 and Article III, § 8, of the By-Laws adopted June 27, 1980) to recommend to the shareholders the dissolution of the Corporation, pursuant to *IDAHO CODE* § 30-1-1402(2), to be effective June 30, 2010. Finally, the Corporation's president is directed, if the shareholders properly approve the Dissolution Recommendation and without any further action of the Board of Directors, to prepare, sign and file Articles of Dissolution with the Idaho Secretary of State in accordance with *IDAHO CODE* § 30-1-1403.
