ALL MEN BY THESE PRESENTS: That we, the undersigned all being full-age citizens of the United states and incorporators,/all being residents of the State of Idaho, do hereby certify that we have this day voluntarily associated ourselves together for the purpose of forming a corporation under and in compliance with the laws of the State of Idaho, and do hereby adopt the following a TIBLES OF INCORPORATION, to-wit:

ETICLE I.

The name of this corporation shall be and is "VALLLY A-I AUTO SLLVAGE, INC."

ARTICLE 11.

The surgoses for which this corporation is formed are the following:

- (a) To engage in the business of the operation of an autowrecking and auto salvage business and to engage in the selling and dealing with new and used auto parts and new and used automobiles of any type or kind.
- (b) To engage in the business of buying, selling or otherwise dealing in, goods, wares and merchandise of any type or kind, either at wholesale or retail.
- (c) To buy, well, own, hold, lease, improve and deal in real estate or personal property of any type and description, whether or not the same is used in connection with any of the purposes of the corporation listed herein.
- and all buildings, structures and plants that may be deemed suitable to the furtherance of the foregoing or any purposes for which the compration is formed, and to we rate manage control.

rent, sell or otherwise dispose of the same.

- (e) To incur indebtedness in such amount as may be deemed necessary, and to borrow money; to evidence such or any indebtedness by the bonds or other written obligations of the corporation; and to secure the payment thereof by mortgage, deed of trust, or other form of encumbrance upon all or any part of the property, real or personal, of the corporation, whether owned at the time or afterwards to be accuired.
- (f) To carry on any activity or activities that might be related to any of the above described powers of the said corroration.
- but in any part of the world, as may be deemed and determined by the board of directors from time to time, without limiting any of the objects and furtoses aforestid. It is expressly declared that the corporation shall have and possess all the powers specifically hereinabove enumerated, and also any and all additional or further powers as may be incidental to the carrying out of the same, and also such other rights, privileges and powers granted by the laws of this state to corporations, except such as may be inconsistent herewith; the intention hereof is expressly acctared to be that the powers of this corporation as excressed herein shall be construed as a grant of general powers and not in any sense as a grant of special or limited powers.
- (h) To accuire, invest in, own and dispose of the capital stock of this corporation and of other corporations, and the business property and assets of any jerson, copartnership or corporation.
