ARTICLE I. NAME

The name of this organization, a religious nonprofit corporation, shall be INVOLVE CHURCH, INC. and is associated with Baptist Network Northwest.

ARTICLE II. PURPOSE

Involve Church exists to involve people in an authentic relationship with Jesus Christ. We will work to accomplish the following:

- A. To promote the preaching of the Gospel of the Lord Jesus Christ in order to win people to a personal faith in Him as Savior.
- B. To provide for the worship of God, to teach and preach the Bible, to administer the ordinances of the New Testament, to train, encourage and care for its own members, to maintain a committed Bible-believing Church that serves its community, and to extend the ministry of the Gospel unto all the earth.

ARTICLE III. NON PROFIT ORGANIZATION

No part of any earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons for any reason not authorized by the Board of Directors, except that the corporation shall be authorized and empowered to pay reasonable, measurable, and verifiable competitive compensation for services rendered to the corporation and to make payments and distributions in furtherance of the purposes set forth in Article 2 hereof. No substantial part of the activities of Involve Church shall be dedicated to, or otherwise attempt to influence, United States State or Federal legislation, and the corporation shall not participate or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permissible (A) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or (B) by a corporation, contributions to which are deductible under section 1: 70(c)(2) of the

Internal Revenue Code.

ARTICLE IV. REGISTERED OFFICE AND AGENT

The location of the Corporation is in the City of Nampa, county of Canyon, and in the state of Idaho. The street address of the initial registered office is 7053 Big Foot Rd, Melba, ID 83641. The initial registered agent is Ryan Frank, residing at 7053 Big Foot RD, Melba, ID 83641.

ARTICLE V. DIRECTORS

The leadership team will serve as the the Board of Directors. The Leadership Team will be elected and appointed according to the by-laws. Titles, definitions and job descriptions for leadership team members are written in the bylaws. New titles, definitions and job descriptions shall be added to the By-Laws as needed.

ARTICLE VIII. VOTING MEMBERS

Involve Church will consist of voting members. The eligibility, rights and obligations of the members are defined in the church's bylaws.

ARTICLE IX. PERSONAL LIABILITY

No member, officer, or director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers, or directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE X. DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to Northwest Baptist Home Mission or a church within the Baptist Network Northwest. If neither of these organization exist assets shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE XI. MEETINGS

Meetings for worship, prayer, praise, fellowship, business, and special purposes shall be held as set forth in the by-Laws.

ARTICLE XII. AMENDMENTS

The articles of incorporation, by-laws, and statement of beliefs may be amended by a two-thirds vote of members present and voting at any business meeting, provided


such amendments have been submitted in writing at a previous business meeting.
