ARTICLES OF INCORPORATION OF

EQUINE ASSISTED SUBSTANCE ABUSE PREVENTION, aka E.A.S.A.P., INC

THE UNDERSIGNED, acting as the incorporator of a corporation under the provisions of the Idaho Nonprofit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the Corporation is

ARTICLE II

The duration of the Corporation is perpetual.

ARTICLE III

3.1 Purpose. This Corporation is organized exclusively for charitable, religious, educational, or scientific purposes under section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, including for such purposes: (1) address the need for the advancement of education in- and the application of- Equine Assisted Substance Abuse Prevention as a means to aid in the prevention of substance abuse and addiction among the adolescent population; (2) disseminate effective principles of substance abuse prevention as outlined by the National Institute for Drug Abuse (NIDA), and The Dept of Health & Human Services' Substance Abuse and Mental Health Services Administration, (SAMHSA) Center for Substance Abuse Prevention (CSAP) and certification standards in equine assisted substance abuse prevention; (3) educate the public regarding the benefits of equine assisted substance abuse prevention; and toward these ends to do all acts and things necessary, conducive, incidental, or advisable to accomplish any of purposes for which this Corporation is formed, including but not limited to, any powers now or hereafter conferred upon or allowed by the Idaho Nonprofit Corporation Act; PROVIDED, that the Corporation shall not carry on a business, trade, avocation, or profession for profit.

3.2 Limitations.

- (a) The Corporation shall have no capital stock, and no part of its net earnings shall inure to the benefit of any Trustee, Director, Officer, or Member of the Corporation or any private individual.
- (b) No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation except as may be permitted to Section 501(c) (3)

organizations by the Internal Revenue Code, and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

(c) Notwithstanding any provision of the Corporation's Articles of Incorporation or Bylaws, the Corporation shall not conduct or carry on activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code as now stated, or as it may be hereafter amended, or by organization contributions which are deductible under Section 1709(c)(2) of such Code as now stated, or as it may be hereafter amended.

ARTICLE IV

In the event of dissolution or final liquidation of this Corporation, all property and assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE V

The conditions and regulations of membership and the rights and other privileges of the classes of memberships shall be determined and fixed by the Bylaws.

ARTICLE VI

The address of the initial registered office of the Corporation shall be 119 Liberty Reach Road, Stites, Idaho 83552. The name of the initial registered agent of the Corporation at such address shall be Marla Mortimer.

ARTICLE VII
