

## CERTIFICATE OF INCORPORATION

I, FRED E. LUKENS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

MONTPELIER CHAMBER OF COMMERCE, INC.

was filed in the office of the Secretary of State on the twenty-seventh day of October A. D. One Thousannd Nine Hundred and thirty and is duly recorded in Book A-24 of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 3 of Chapter 262 of the 1929 Session Laws of Idaho, and Sections 4865 to 4869, inclusive, Idaho Compiled Statutes.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for a term of fifty years from the date hereof, with its registered office in this State located at Montpelier in the County of Bear Lake, and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative

Associations, as provided in Chapter 195, Idaho Compiled Statutes.

Be IT KNOWN THAT WE, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the state of Idaho.

And we hereby certify:

First. That the name of said corporation is the Montpelier Chamber of Commerce, Inc.

Second. That the purposes for which it is formed are to foster, promote and protect the progress and prosperity of the commercial, agricultural, and general business interests of the citizens of the City of Montpelier, County of Bear Lake, and the State of Idaho, and to render such assistance as may be in its corporate power to the up-building and betterment of the inhabitants of the communities herein mentioned. That said corporation is not organized for profit.

Third. That the place where its principal business is to be transacted shall be Montpelier, County of Bear Lake, State of Idaho

Fourth. That the term for which it is to exist is Fifty (50) years from after the date of its corporation.

Fifth. That the number of its Directors or Govenors shall be seven, and the names and residences of those who are appointed for the first year are: walter Hansen, Montpelier, Idaho; Delbert Jones, Montpelier, Idaho; F. M. Williams, Montpelier, Idaho; H. R. Toomer, Montpelier, Idaho; Exx Geo. F. Ashley, Montpelier, Idaho; Thomas Stephens, Montpelier, Idaho, and H. R. Groo, Montpelier, Idaho.

Sixth. That the said named Directors or Govenors were duly elected at a meeting of the members of said association, which said meeting was held on the 15th day of September, 1930, and which said meeting was held in the City of Montpelier, Idaho, and said Directors or Govenors received a majority of the votes cast for said office at said meeting.

Seventh. That the said association shall be made up of the individual members who subscribed to the constitution and by-laws of the said association, each member being entitled to one and only one vote. Said membership shall not be transferable.

Eighth. That said corporation has no capital stock or shares representing stock.
