

ARTICLES OF INCORPORATION
OF THE
SUNSET BREWING COMPANY.

KNOW ALL MEN BY THESE PRESENTS: That we, David Holman, Joseph A. Neubens, of the City of Spokane, State of Washington, and Jacob Lockman, Frieda Lockman and J. Henry Beckman of the City of Wallace, in the County of Shoshone, State of Idaho, do hereby voluntarily associate ourselves together for the purpose of forming a corporation and becoming a body corporate under the laws of the State of Idaho, and we hereby declare and set forth:

- 1st. The name of this corporation is and shall be the SUNSET BREWING COMPANY.
- 2nd. This corporation is formed for the purpose of manufacturing lager beer and other malt products, and to deal in, buy and sell spirituous, vineous and malt products, and to bottle, bag and barrel such goods, and to conduct general wholesale and retail liquor business, and to deal in bar fixtures and wares, furniture, glass and other wares, cigars, tobacco and saloon supplies, and to deal in ice. Also to purchase, own, hold and sell real estate, and to locate and claim such real estate or possessory rights, also to purchase, own, hold and sell personal property, of any kind of business in the State of Idaho, or elsewhere. Also for the purpose of leasing real and personal property.
- 3rd. The principal place of business of this corporation shall be in the city of Wallace, in the County of Shoshone, State of Idaho.
- 4th. This corporation shall exist for the term of fifty years.
- 5th. The Directors of this corporation shall consist of

five, each of whom must be a stockholder in this corporation. The names and residence of those who are appointed for the first year, or until the annual meeting of the stockholders, or until they shall be disqualified, are as follows:-

David Neisman, Spokane, Washington, Director and President;

Joseph A. Rubens, Spokane, Washington, Director and Vice President;

Jacob Lockman, Wallace, Idaho, Director, Secretary and Treasurer;

Prioda Lockman, Wallace, Idaho, Director;

J. Henry Beckman, Wallace, Idaho.

6th. The amount of the capital stock of this corporation shall be seventy five thousand dollars, and shall be divided into seven hundred shares of the par value of one hundred dollars per share.

7th. That all of the capital stock of this corporation is initially subscribed by the following named persons for the amount of shares set opposite the respective name of each, to-wit:

Two thousand five hundred shares; and fifty

Joseph A. Rubens,

Two thousand five hundred shares; and forty

Jacob Lockman,

Two hundred shares;

Prioda Lockman,

Four hundred, ninety nine shares;

J. Henry Beckman,

One share.


