ARTICLES of AMENDMENT:

This amendment is to alter Section III of the original articles of incorporation which read as follows: "Section III, The term for which it is to exist is fifty years from it's incorporation."

The said Section III as amended will read as follows: The term for which it is to exist is, Perpetual.
