1. CHAPTER NAME

The name of this organization shall be the Emergency Nurses Association Snake River Chapter INC., a not for profit corporation, incorporated in the State of IDAHO, hereinafter referred to as the Chapter.

2. CHAPTER DURATION

The duration of the Chapter shall be perpetual.

3. CHAPTER PURPOSE AND OBJECTIVES

- A. To promote and to implement the philosophy and objectives of the National Emergency Nurses Association (ENA) on the chapter level.
- B. To provide leadership by identifying and addressing issues affecting emergency care and emergency nursing practice on the chapter level.
- C. To monitor local legislative issues affecting emergency care and emergency nursing practice.
- D. To provide continuing education opportunities at the chapter level.
- E. To implement all National Association <u>Bylaws</u> and <u>Procedures</u> at the chapter level.
