ARTICLES OF INCORPORATION  
OF  
DOUBLE L LOGGING CO.

KNOW ALL MEN BY THESE PRESENTS: I, the undersigned, being a natural person of full age and citizen of the United States, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, particularly Idaho Code Title 30, Chapter 1, and to that end hereby adopt Articles of Incorporation as follows:

I.

NAME

The name of the Corporation is DOUBLE L LOGGING CO.

II.

PURPOSES

The purposes of the Corporation are:

To have and to exercise all of the powers now or hereafter conferred by the laws of the State of Idaho upon corporations organized pursuant to the laws under which the corporation is organized and any and all acts amendatory thereof and supplemental thereof.

To conduct and carry on the business of logging, to engage in all facets and areas of the logging business, to buy, sell, lease

and otherwise deal in logging materials and equipment of every type and description, and to buy, sell and lease and develop real property.

To engage in any other lawful activity.

To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes, the attainment of any of the objects, the exercise of any of the powers herein set forth, either alone or in conjunction with other corporations, firms, or individuals, and either as principals or agents, and to do every other act or acts, thing or things, incidental or pertinent to or growing out of or connected with the above mentioned objects, purposes or powers.

III.

#### DURATION

The duration of the Corporation is perpetual.

#### REGISTERED AGENT AND OFFICE


