CENTRAL ASSEMBLY CHRISTIAN LIFE CENTER, INC.

On September 20, 1987 at a special business meeting of the assembly, duly announced and posted two weeks in advance, a quorum being present, a resolution was adopted by an unanimous vote that the following articles be added to the corporation's "Articles of Incorporation" as filed on May 24, 1956.

ARTICLE VII

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable, educational, religious and/or scientific purposes and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

ARTICLE VIII

This organization is organized exclusively for religious purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

ARTICLE IX


Notwithstanding any other provisions of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by any organization contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE X

This organization in its congregation or in any of its outreaches including Maranatha Christian School admits members and students of any race, color, national and ethnic origin to all the rights, privileges, programs, and activites generally accorded or made available to all other members and students.
