I.

That the name of this corporation is "Friends Church of Star."

II.

formed are to purchase, receive, hold, sell, convey and mortgage such real or personal property as said Friends Church
may require, need or use for the purposes of carrying out the
religious, benevolent, charitable and other objects of said
church according to the customs, rules, regulations, covenants and faith of said Friends Church; to give promissory
notes, secured or unsecured, by mortgage, trust deed or other
form of incumbrance, on any or all of its property, personal
or real, for the purpose of raising funds to build any church
or other building necessary for the use of said Friends Church,
or to be used in carrying out any of the religious, benevolent

or charitable work of said church, or to purchase ground upon which such building, or buildings, may be erected, or to pay any debts emisting against said Friends Church before its incorporation, or any debt it may hereafter contract in furtherance of the purposes for which it is incorporated; to incur any necessary debt or obligation, and to execute and deliver the notes or other obligations of said Friends Church therefor; to inculcate and spread the religious doctrine of said Friends Church and to encourage the growth and effusion of its principles and teachings.

III.

That the place where its principal business is to be transacted is at the Village of Star, County of Ada, State of Idaho.

IV.

That the term for which this corporation is to exist is fifty (50) years, from and after the date of its incorporation.

That there is no capital stock, or shares of stock, to be issued by this corporation, and that it is formed entirely for religious, benevolent and charitable purposes, and not for profit.
