The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Organization do hereby certify:

FIRST: The name of the Organization shall be Parent Education Center, Inc.

SECOND: The place in this state where the principal office of the Organization is to be located is the City of Boise, Ada County. *Katherine Widner (1910 University Dr.) Boise, Id. 83725*

THIRD: Said organization is organized exclusively to provide Parent Education in the Boise area under the auspices of Boise Schools and Boise State University, organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law.)

FOURTH: The names and addresses of the persons who are the initial trustees of the corporation are as follows: Dr. Katherine Y. Widner, *(2024 Lemmon Blvd Boise, Id. 83705)* Executive Director; *(525 Ash, Boise, Id. 83704)* Dr. John H. Jensen, Assistant Director; Loyle Washam, Assistant Director; *(3717 Bycamere Dr. Boise, Id. 83703)* Barbara Garrett, Secretary-Treasurer. *(580 Anderson Ave Boise, Id. 83706)* *Incorporators are the above.*

FIFTH: No part of the funds of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Director shall be authorized and empowered to pay reasonable compensation for services rendered. No substantial part of the activities of the corporation shall be the carrying on of propoganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the Parent Education Center shall not carry on any other activities not permitted to be carried on by an Organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

SIXTH: Upon the dissolution or liquidation of the Organization, any assets, in any form whatsoever in excess of liabilities, shall be divided on an equal basis between Boise Schools and Boise State University, exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).
