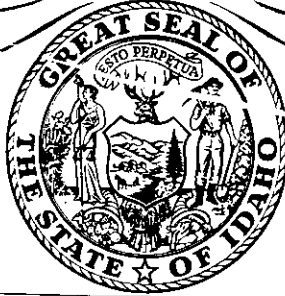

CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

was filed in the office of the Secretary of State on the **Twenty-sixth** day
of **March** A. D. One Thousand Nine Hundred **Sixty-four** and
is duly recorded on Film No. **127** of Record of Domestic Corporations, of the State
of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and
Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and
successors are hereby constituted a corporation, by the name hereinbefore stated, for
perpetual existence from the date hereof, with its registered office in this State located at
Kooskia in the County of **Idaho,**
and as such are subject to the rights, privileges and limitations granted to Non-Profit Coopera-
tive Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION
OF
THE KAMKOO FLYING CLUB, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, citizens of the United States, and residents of Kooskia, Idaho County, Idaho, do hereby associate ourselves together to form a non-profit corporation, and in order to form a corporation for the purposes hereinafter stated under the provisions of Chapter 10 of Article 30, Idaho Code, and the laws of the State of Idaho relating to the organization of corporations where pecuniary profit is not the object, do hereby CERTIFY AND DECLARE as follows:

I.

The name of this corporation is, THE KAMKOO FLYING CLUB, INC.

II.

The purposes and objects for which the corporation is formed are, without pecuniary profit, to provide economical private flying for all its members; to hold title to all property which said Corporation may now own or may hereafter acquire and for said purposes and to that end to buy, sell, acquire, own mortgage, hypothecate, transfer, lease, exchange, trade or otherwise acquire or dispose of, real and personal property and otherwise do all acts and things necessary or convenient in or about the conduct, management and carrying on of such activities, objects and purposes, and to make, perform and carry out contracts and agreements for any lawful purpose, to the same extent and as fully as natural persons might or could do, and to do, perform and carry on its business as principal, agent, trustee or otherwise, and either alone or in conjunction with any other person, firm, association, corporation and with agencies, departments and officers of the State and Federal Government.

III.

This Corporation shall have perpetual existence.

IV.

The location and post office address of the registered office of the Corporation is: Kooskia, Idaho County, Idaho.

V.

This Corporation is not organized for pecuniary profit and it shall not have or issue any capital stock.

VI.

The number of directors of the corporation shall be as specified in the By-laws, but not less than three, and such number from time to time may be increased or decreased in such manner as may be prescribed in the By-laws. In case of an increase in the number of directors, the additional directors may be elected by the directors then in office, and a director so elected by the directors then in office, shall hold office until the next annual meeting of the members, and until his successor is elected and qualified.

VII.

Each member in good standing of the KamKoo Flying Club, Inc., Kooskia, Idaho, county, Idaho, shall be and continue to be a member of this Corporation, and the rights and interests of all members shall be equal, and no member can have or acquire a greater interest therein than any other member. The association shall issue membership certificates to each member thereof, which certificates cannot be assigned so that the transferee thereof can by such transfer become a member of the association, except by resolution of the board of directors and under such regulations as the By-laws may prescribe.
