That we, the undersigned, being citizens of the United States of America, and being persons of full legal age, have this day voluntarily associated ourselves together for the purpose of forming a domestic corporation under and pursuant to the laws of the State of Idaho, and do hereby certify as follows:

The name of this corporation shall be Reinco, FIRST: Inc.

The purposes for which this corporation is SECOND: formed are as follows:

- A. To engage in any lawful business activity for which corporations may be organized under the laws of the State of Idaho including, but not limited to, a general construction and contracting business.
- To do and perform any act, matter or anything necessary, proper or convenient for the accomplishment of the purpose of the corporation.
