



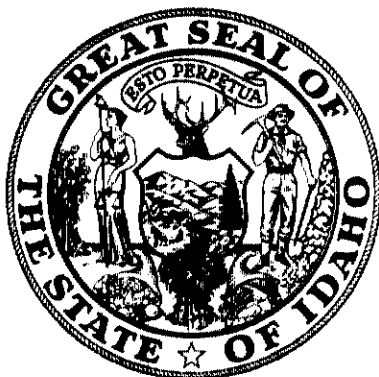
CERTIFICATE OF INCORPORATION

3 KNOW ALL MEN BY THESE PRESENTS:

4 That we, the undersigned, being citizens of the United
5 States of America, and being persons of full legal age, have
6 this day voluntarily associated ourselves together for the
7 purpose of forming a domestic corporation under and pursuant to
8 the laws of the State of Idaho, and do hereby certify as
9 follows:

10 FIRST: The name of this corporation shall be Reinco,
11 Inc.

12 SECOND: The purposes for which this corporation is
13 formed are as follows:

14 A. To engage in any lawful business activity for which
15 corporations may be organized under the laws of the State of
16 Idaho including, but not limited to, a general construction and
17 contracting business.

19 necessary, proper or convenient for the accomplishment of the


