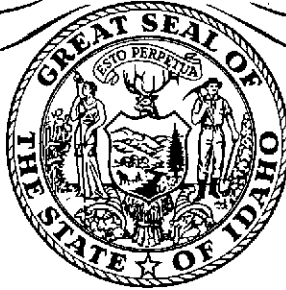

WHEREAS, there was issued by the Secretary of State, a Charter dated April 5, 1950, constituting and creating Inkome Elevator, Inc., under the laws of this State, with its principal place of business at Pocatello, Bannock County, Idaho, and with a capital stock of \$25,000.00 Dollars, divided into 250 shares at \$100.00 Dollars par value.

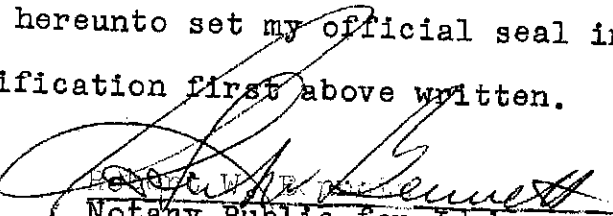
