Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act and Sections 41-2804 and 41-2805 of the Idaho Insurance Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Idaho Teachers Mutual Insurance Company.

SECOND: The following amendments of the Articles of Incorporation are hereby adopted by the statutory receiver of the corporation on September 29, 1980, in the manner prescribed by the Idaho Business Corporation Act:

ARTICLE X


Pursuant to § 41-2804(3), Idaho Code, the maximum contingent liability of the members of this corporation, for payment of losses and expenses incurred, other than as to non-assessable policies issued as permitted under § 41-2849, Idaho Code, shall be in the amount of one (1) annual premium for the member's policy.

THIRD: The corporation has no shares and has been, since September 25, 1980, subject to an order of rehabilitation.
