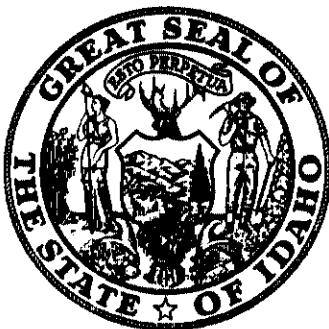

**AMENDMENT OF ARTICLES OF INCORPORATION
SECTIONS V AND X
OF
DISABILITY ACTION CENTER - NORTHWEST, INC.**

On March 9, 1993, at a special meeting of the initial Board of Directors of the membership corporation (there being no members other than the initial directors), Disability Action Center - Northwest, Inc., on a motion duly made and seconded the following resolution was adopted:

Be it resolved that we, the undersigned, do hereby approve amendment of the Articles of Incorporation to delete the last paragraph of Section V., and to correct the first word of the second paragraph of the same Section to be spelled "To", instead of "Too". The new Section V. should read as follows:

V.

The corporation shall have all of the powers allowed by law and is specifically empowered:

To buy, own, sell, assign, mortgage or lease any interest in real estate and personal property and to construct, maintain and operate improvements thereon necessary or incident to the accomplishment of the purposes set forth in Article IV hereof.

To borrow money and issue evidence of indebtedness in furtherance of any or all of the objects of its business, and to secure the same by mortgage, pledge or other lien on the corporation's property.

To do and perform all acts reasonably necessary to accomplish the purposes of the corporation, including signing contracts with state and federal granting authorities for funds necessary for implementation of activities listed in Article IV.

We also wish to amend the first part of Section X by deleting the word, "five," and replacing it with "nine" to read as follows:

X.

The number of directors constituting the initial Board of Directors of the corporation is nine (9), and the names and addresses of the persons who are to serve as directors until the first annual meeting of members or until their successors are elected and shall qualify are: ...

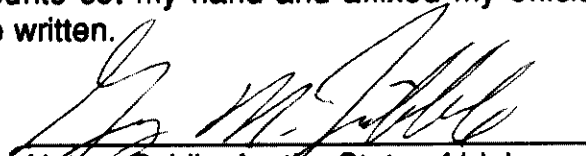
