ARTICLES OF INCORPORATION

1 KNOW ALL MEN BY THESE PRESENTS:

2 That we, the undersigned, citizens and residents of the
3 United States of America, and each over the age of 18 years, do
4 by these presents, voluntarily associate ourselves together for
5 the purpose of forming a corporation, as hereinafter stated,
6 pursuant to and under the laws of the State of Idaho, and do
7 hereby execute and deliver these Articles of Incorporation for
8 that purpose.

9 WE HEREBY SET FORTH, DECLARE AND CERTIFY:

10 ARTICLE I

11 NAME

12 This corporation shall be known as "MALLORY TRUCK LINES,
13 INC.". 14

15 ARTICLE II

16 OBJECTS AND PURPOSES

17 The objects and purposes for which this corporation is
18 formed are as follows:

19 (a) To engage in the business of a common motor
20 carrier, and to offer hauling, and carriage services
21 for freight and goods within our licensed authoriza-
22 tion and capabilities; and to generally engage in
23 the business of transporting goods for hire.

24 (b) To engage in any commercial, industrial
25 or agricultural enterprise, calculated or
26 designed to be profitable to this corporation,
27 and in conformity with the laws of the State of
Idaho, or such other place or places and states
in which the corporation may, from time to time,
conducts its business.

28 (c) To purchase, lease, own, sell, mortgage,
29 sublease, and otherwise acquire lands, buildings,
30 easements or property, real and personal, which
31 may be requisite for the purposes of or capable
32 of being conveniently used in connection with
any of the objects of this corporation, and to
enter into, make, perform, carry out contracts
of every sort and kind, with any person,
including the right to become a partner or

1 interested in a joint venture, and to acquire
2 and take over the good will, property, rights,
3 franchises, and assets of every kind, and
4 liabilities of any person, firm, association
or corporation, either wholly or in part, and
to pay for the same in cash, stocks, bonds of
the corporation, or otherwise.

5 (d) To organize or cause to be organized under
6 the laws of any state of the United States, or
7 the District of Columbia, or of any territory,
dependency, or possession of the United States,
or of any foreign country, a corporation or
corporations for the purpose of transacting,
promoting or carrying on any or all of the
objects or purposes for which this corporation
is organized, and to dissolve, wind up, liquidate,
merge, or consolidate any such corporation or
corporations, or to cause the same to be dissolved,
wound up, liquidated, merged or consolidated.

11 (e) To do all and every thing necessary, suitable,
12 and proper for the accomplishment of any of the
13 purposes or the attainment of any of the objectives,
14 or the furtherance of any of the powers hereinbefore
15 set forth, either alone or in association with
16 other corporations, firms or individuals, and
17 to do every other act, or acts, thing or things,
18 incidental or pertinent to or growing out of,
19 or connected with the foregoing objects or
20 purposes, or any part or parts thereof, provided
21 the same be not inconsistent with the laws under
22 which this corporation is organized.

23 (f) The provisions of these Articles shall be
24 construed as purposes and powers, and each as
25 an independent purpose and power in furtherance
26 of, and not in limitation of, the powers which
27 the corporation may have under present or future
28 laws of the State of Idaho, and in such states
29 as the corporation may, from time to time, do
30 business.

31 (g) To have and to exercise all rights and powers
32 from time to time granted to a corporation by law.

26 The term and existence of this corporation shall be

5 The total number of shares which the corporation is

7 with no par value per share.

10 ARTICLE VI

11 CHARACTERISTICS OF STOCK

12 The holders of the common stock are entitled to all
13 dividends declared by the Board of Directors, each stockholder of
14 common stock of record shall be entitled in all meetings of the
15 corporation or in matters requiring a vote, to one (1) vote for
16 each share of stock standing in his name upon the books of the
17 corporation.

18 The holder of shares of any class of this corporation
19 shall, upon sale by authorization of the corporation, for cash
20 or shares of the same class, have the right, during a reasonable
21 time to be fixed by the Board of Directors, to purchase shares
22 in proportion to their respective holdings of shares of such
23 class, at such price as may be fixed therefore by the Board of
24 Directors, but at not less than par for par value shares.

25 All stock, when fully paid, shall be non-assessable.

26 The corporation may purchase its own stock.

27 ARTICLE VII

14 (3) Directors, and not more than seven (7), except that if all of
15 the shares of the corporation are owned beneficially and of record
16 by either one or two stockholders, the number of Directors may
17 be less than three, but not less than the number of stockholders.
18 A majority of the Board of Directors shall constitute a quorum
19 for transacting business, and the act of the majority of such
20 quorum of said Board of Directors shall be the act of the Board.
21 The Directors need not be stockholders of the corporation.

AMENDMENT

24 These Articles of Incorporation may be amended in
25 accordance with the provisions of the statutes of the State of
26 Idaho, then in full force and effect; the power to make and repeal
27 and amend the By-Laws, and adopt new By-Laws, is hereby conferred
28 upon the Directors as well as the shareholders.




30 No contract or other transaction between this corpora-
