KNOW ALL MEN BY THESE PRESENTS, THAT WE, THE UNDERSIGNED BEING
NATURAL PERSONS OVER THE AGE OF EIGHTEEN (18) YEARS, DO HEREBY FORM
A GENERAL BUSINESS CORPORATION UNDER THE LAWS OF THE STATE OF IDAHO
AS CONTAINED IN TITLE 30 OF THE IDAHO CODE ENTITLED "GENERAL
BUSINESS CORPORATION ACT", AND TO THAT END DO HEREBY SET FORTH:

1. THE NAME OF THE CORPORATION IS: ROCKLAND OIL CO., INC.
2. THE PERIOD OF DURATION OF THIS CORPORATION SHALL BE PERPETUAL.

3. THE PURPOSES FOR WHICH THIS CORPORATION IS ORGANIZED:

(A) PRIMARILY TO ENGAGE IN THE BUSINESS OF OPERATING A
GAS STATION, GARAGE AND BULK PLANT.

(B) THE TRANSACTION OF ANY OR ALL LAWFUL BUSINESS FOR
WHICH CORPORATIONS MAY BE INCORPORATED UNDER THE IDAHO BUSINESS
CORPORATION ACT.

4. THE COUNTY IN THE STATE OF IDAHO WHERE THE PRINCIPAL
OFFICE FOR THE TRANSACTION OF BUSINESS OF THE CORPORATION IS
LOCATED IS IN THE COUNTY OF POWER AND THE NAME OF THE REGISTERED
AGENT IS MERRILL WALKER, AND THE ADDRESS OF THE REGISTERED OFFICE

5. THE AGGREGATE NUMBER OF SHARES WHICH THE CORPORATION SHALL

SHARE. ALL OF SAID STOCK SHALL BE KNOWN AS COMMON STOCK AND SHALL
BE NONASSESSABLE.
