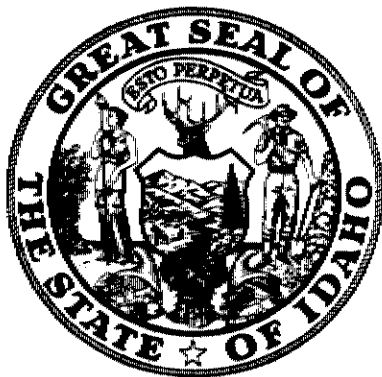

ARTICLES OF INCORPORATION

The undersigned, acting as an incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. NAME: The name of the corporation is KECHTER SALES, INC.

2. DURATION: The period of its duration is perpetual.

3. PURPOSE: The purpose or purposes for which the corporation is organized are the transaction of all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

4. CAPITAL: The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares which shall be without par value. All stock is common stock and all stock is voting stock.

5. PRE-EMPTIVE RIGHTS: There are no provisions denying pre-emptive rights.

6. INTERNAL AFFAIRS: There are no special provisions regulating the internal affairs of the corporation.
