ARTICLES OF INCORPORATION

OF *JAN 10 1981*  
BRIGHT CONSTRUCTION CO., INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, acting as incorporators under the Idaho Business Corporation Act, adopt the following Articles of Incorporation.

Section 1

The name of the Corporation is BRIGHT CONSTRUCTION CO., INC.

Section 2

The period of its duration is perpetual.

Section 3

Corporate Purpose

The nature of the business or purposes to be conducted or promoted are to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Idaho.

To purchase, receive by way of gift, subscribe for, invest in, and in all other ways acquire, import, lease, possess, maintain, handle on consignment, own, hold for investment or otherwise use, enjoy, exercise, operate, manage, conduct, perform, make, borrow, guarantee, contract in respect of, trade and deal in, sell, exchange, let, lend, export, mortgage, pledge, deed in trust, hypothecate, encumber, transfer, assign and in all other ways dispose of, design, develop, invest, improve, equip, repair,

alter, fabricate, assemble, build, construct, operate, manufacture, plant, cultivate, produce, market, and in all other ways (whether like or unlike any of the foregoing), deal in and with property of every kind and character, real, personal, or mixed, tangible or intangible, wherever situated and however held, including, but not limited to money, credits, choses in action, securities, stocks, bonds, warrants, script, and other obligations and evidences of interest in or indebtedness of any person, firm or corporation, foreign or domestic, or of any government or subdivision or agency thereof, documents of title, and accompanying rights, and every other kind and character of interest therein and appurtenance thereto, including, but not limited to, mineral, oil, gas, and water rights, all or any part of any going business and its incidents, franchises, subsidies, charters, concessions, grants, rights, powers, or privileges, granted or conferred by any government or subdivision or agency thereof, and any interest in or part of any of the foregoing, and to exercise in respect thereof all of the rights, powers, privileges, and immunities of individual owners or holders thereof.

To carry on any business whatsoever that this Corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly to improve the interests of this Corporation, and to have and to exercise all powers conferred by the laws of the State of Idaho on corporations formed under the laws pursuant to which and under which this corporation is formed, as

such laws are now in effect or may at any time hereinafter be amended, and to do any and all things hereinabove set forth to the same extent and as fully as natural persons might or could do, either alone or in connection with other persons, firms, associations, or corporations, and in any part of the world.

Section 4

Stock

The aggregate number of shares which the corporation shall have authority to issue is 100 shares of common stock at the par value of \$1.00 per share.

Section 5

Corporation Regulations

The internal affairs of BRIGHT CONSTRUCTION CO., INC., shall be regulated by such by-laws as may be provided for the corporation and in addition shall be regulated in accordance with the provisions of the Idaho Business Corporation Act, Section 30-1-23(a).

Section 6

Registered Office

The address of the initial registered office of BRIGHT CONSTRUCTION CO., INC., is Mink Creek Road, City of Pocatello, State of Idaho, and the name of its initial registered agent is MICHAEL G. BRIGHT.

Section 7

Corporate Directors


The number of directors constituting the initial Board of Directors of BRIGHT CONSTRUCTION CO., INC., is two (2). These


