The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for this corporation:

I.

The name of this corporation shall be John's Repair, Inc.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The address of the initial registered office of this corporation is 4910 Irving, Boise, Idaho 83706, and the name of the initial registered agent at such address is William L. Woolley.

IV.

The nature of the business and the object and purpose of this corporation shall be as follows:

To engage in the automative repair business; to engage in automotive, truck, and equipment leasing; and to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
