FIRST

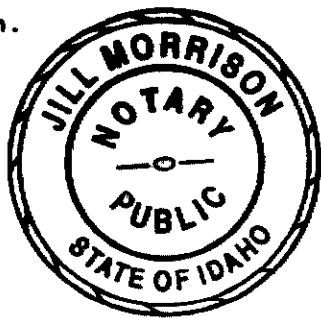
