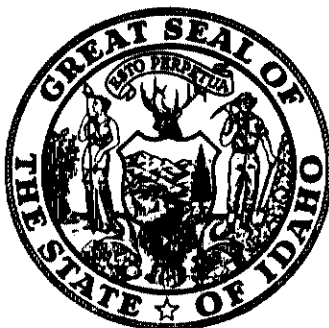
CERTIFICATE OF AMENDMENT OF

Intermountain Northwest Construction, Inc., a company organized and existing under the laws of the State of Idaho, hereby certifies as follows:


1. The name of the corporation is "Intermountain Northwest Construction, Inc."


"ARTICLE I.

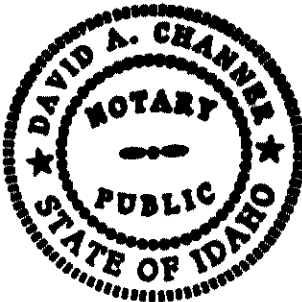

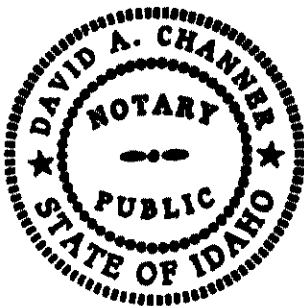
