The undersigned, duly licensed to provide counseling in the State of Idaho desires to form a professional corporation pursuant to Idaho Code § 30-1301 et seq., for the purpose of rendering counseling services and adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of this corporation shall be SAFE HARBOR COUNSELING, P.C.

ARTICLE II

PURPOSE

The purpose for which this corporation is formed is to engage in the general practice of counseling with an emphasis in the area of family and children counseling.

In connection with the practice of counseling, the corporation shall have the power to invest its funds in real estate, mortgages, stocks, bonds or any other type of investments, and to dispose of the same; and, to own real and personal property necessary for the rendering of professional services.

In addition, said corporation may engage in any activity permitted under Chapter 13 of Idaho Code § 30-1301 et seq.

DIRECTORS

The corporation shall not begin business until the sum of \$500 has been received for the issuance of shares.
