CERTIFICATE OF AMENDMENTS

TO THE

ARTICLES OF INCORPORATION

OF

THE CHRISTIAN CHURCH OF COEUR D' ALENE, IDAHO

KNOW ALL MEN BY THESE PRESENTS, that at a special meeting of the members of the Christian Church of Coeur d' Alene, Idaho, an Idaho religious corporation, held at the said church building in Coeur d' Alene, Idaho, immediately following the regular church services on Sunday, the 9th day of January, 1955, pursuant to a notice given by publication for four consecutive weeks in the Coeur d' Alene Press, a legal newspaper published at Coeur d' Alene, Kootenai County, Idaho, the city where said meeting was held and by posting a like notice in a conspicuous place in said church building, where the meeting was held, for a similar length of time, which notice stated the time and place of holding such meeting and the manner in which it was intended to amend the Articles of Incorporation, by a motion duly made, seconded and unanimously adopted, the first and fourth articles of the said Articles of Incorporation were amended to read as follows:

"First. That the name of this corporation shall be "The First Christian Church of Coeur d' Alene, Idaho."

"Fourth. That the term of its existence shall be perpetual."

IN WITNESS WHEREOF, the chairman and secretary of the Board of Trustees of said corporation have hereunto set their hands on this 14th day of January, 1955, at Coeur d' Alene, Idaho.
