ARTICLES OF INCORPORATION
OF STATE

H.M.M., INC.

THE UNDERSIGNED, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is H.M.M., INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000, \$1.00 par value.

FIFTH: There are no provisions denying preemptive rights.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are the By-laws of the Corporation.

SEVENTH: The address of the initial registered office of the Corporation is 6257 Morris Hill Road, P. O. Box 8802, Boise, Idaho, and the name of its initial registered agent at such address is V. K. Kelley.
