

Articles of Incorporation
of the

Skinner Irrigation Company.

First: -- the name of this corporation shall be the "Skinner Irrigation Company."

Second: -- This corporation is formed for the purpose of constructing dams and reservoirs for the storage of the waters of Skinner Creek, Juest Creek, Swift Creek, ^{and spring creek} and for the purpose of constructing ditches, flumes, canals and water ways for the conveyance of waters of said creeks to, over and upon the lands owned by the stockholders of this corporation situated in Mountain, Bear Lake County, State of Idaho, and in the vicinity thereof. Said waters to be used for agricultural and ordinary purposes and for propelling machinery.

Third: -- The place where the principal business of this corporation is to be transacted is Mountain, Bear Lake County, State of Idaho.

Fourth: -- This corporation is to exist for a period of thirty years.

Fifth: -- The corporate powers of this corporation shall be vested in a board of five directors, and the following named persons are appointed for the first year or until such time as the by-laws adopted by this corporation shall designate for the holding of next annual meeting at which their successors shall be elected, viz:

Sixth: -- That the amount of the capital stock of this corporation shall be Eight Thousand Five Hundred Dollars, which shall be divided into eight hundred and fifty shares of ten Dollars each.

Seventh: -- The amount of capital stock actually subscribed is Eight Thousand Five Hundred Dollars, and each of the following named persons has subscribed the amount of said stock, set opposite his name, so-wit:
